# Thomas H. Hyde (b. c.1851 - d.1920) of Missouri and his Ancestors in Derbyshire OR John Hyde of Cheshire/Derbyshire

# and his Descendants in Iowa and Missouri

The Advertiser-Courier of Hermann MO on Wed April 28, 1920, page 1: "Died at Gasconade - Thos H Hyde, aged 70 years, died last Friday at his home in Gasconade. The aged man resided there for the past ten years, and earned a livelihood by doing odd jobs for the neighborhood. He left no property and the good citizens of Gasconade raised a fund to give the body decent burial. Nothing is known about his past or any of his relatives. The body was laid to rest in the Gasconade Cemetery last Saturday."

Although his neighbors did not know of his family, Thomas left two sons surviving him. Entries for Thomas are, for the most part, in reverse chronological order beginning with his death record. Links in this document to Familysearch require a free account sign up. If the reader will log in to Familysearch before clicking a link, the hyperlink will open the relevant document. Links to documents found in Ancestry or Findmypast require a subscription. When possible, links to free sources have been included.

23 April 1920 - T H Hyde, carpenter, divorced, date of death 23 April 1920, age approximately 64 (putting his birth year at 1856, if correct). Parentage and birthplace unknown. Informer John Lumpkin, relationship to deceased not stated. 1920 Federal census (taken 26 Jan 1920) Richland Township, Gasconade County, Missouri, T H Hyde, widowed, born Illinois, age 67 (birth year of 1853 if correct), both parents born in England. Owned his home free of mortgage. Able to read and write. Lives alone. <u>https://www.familysearch.org/ark:/61903/1:1:M8WT-8BG</u>

1910 Federal census Richland Township, Gasconade County, Missouri, for Thomas H Hyde, single, carpenter, age 68 (birth year 1842 if correct), born Illinois, both parents born in England, owned his home free of mortgage, lives alone. Not noted as being a survivor of the Union or Confederate Army or Navy. <u>https://www.familysearch.org/ark:/61903/1:1:M2YM-B86</u>

1900 Federal census Osceola Township, St. Clair County, Missouri, for Thomas Hyde, day laborer, widowed, born March 1842, age 58. According to the census, he and his father were both born in Illinois, mother born in England. He is boarding in the household of Thomas Myres, day laborer, born March 1865 in Illinois, parents both born in Illinois. Thomas Myres was recently widowed and had a 7 year-old daughter Sena and a pair of 1 year-old twins, Ruth and Dollie. <u>https://www.familysearch.org/ark:/61903/1:1:M38X-1FC</u>

Thomas Hyde was married to Susan Dunlap on 11 June 1885 in Osceola Township, St Clair, Missouri. Marriage License <u>https://www.familysearch.org/ark:/61903/1:1:6X63-C4XF</u>

Thomas's wife Susan Hyde is enumerated separately in the 1900 census, living with her three sons Wilson, Levi and Albert Hyde. She was noted as being widowed. It was not uncommon for divorced or separated persons to report to the census taker that they were widowed. <u>https://www.familysearch.org/ark:/61903/1:1:M38F-P8N</u>

Only partial records from the 1890 census remain, and neither Thomas nor Susan appear in surviving records for that census.

More is known about Susan, whose maiden name was Taylor. The Family Search source page for her is here <u>https://www.familysearch.org/tree/person/sources/LVZB-TK4</u> Son Wilson was Wilson Dunlap, Susan's son with her first husband Samuel Dunlap who she married January 1, 1880.

Despite a newspaper notice concerning the divorce of Susan Dunlap from Samuel Dunlap in Clinton, MO in October of 1885 Oct 01, 1885, page 4 - The Clinton Advocate at Newspapers.com, a decree of divorce granted in September 1883 in Henry County Henry. Court Records 1882–1885 recites that an interlocutory judgment was rendered against Susan at the April 1883 term of court. In December 1882 in Henry County, Missouri - S.A. Dunlap vs. Susan Dunlap - Henry. Court Records 1882–1885 - Susan did not respond to the summons and so an "interlocutory decree" was rendered against her and the case was continued until the next term of court. An interlocutory decree of divorce is one that is granted but not effective until after a waiting period - in this case until the next term of court. Please note that Samuel Dunlap's recitation of the facts of his marriage in the court case were off by a year.

Both Levi and Albert (known as Bert) were Susan's children with Thomas Hyde. All three brothers (Wilson, Levi and Albert) appear to have remained close, and Wilson was known as Wilson Hyde. Wilson did not marry, and died at age 35 of tuberculosis per his death record which called him Wilson Hyde, with informant Bert Hyde. <u>1916\_00012007.PDF</u> Levi married Chub "Hattie" Terry (appearing in marriage and census records as Chub, Chub Etta, Hattie and Hettie; marriage record with Levi Hyde mistranscribed as Hattie "Urry" in Ancestry). Bert married Lillie Belle Terry. Hattie and Lillie were sisters, their parents were Samuel and Rachel Terry.

Thomas Hyde could not be located in the 1880 census, he may have been traveling toward Missouri, but from where? He was not consistent concerning the year of his birth, but he

was consistent about his birthplace being Illinois, and one or both parents hailing from England. Census ages are not always correct for a wide variety of reasons, and when his age is adjusted to the early 1850s, in line with what appears on his death record and final census, we find him in the 1870 census in Kennebec, Monona County, Iowa, a laborer, age 19, living with his parents Davis and Anna, both from England. https://www.familysearch.org/ark:/61903/1:1:MDVG-MJF Next door to them are two immigrants from England, Edward Merida<sup>1</sup> and John Birthwait (spelled Braithwaite in land records), and the Myres (spelled Myers in land records) family from Pennsylvania. It's possible that this Myres family is related in some way to the Thomas Myres that Thomas Hyde was living with in the 1900 census. Parents "Davis" and "Anna" Hyde turn up in no other US records, leading to a search for records at the county level where their names were accurately recorded. A match was found in Monona County land records, leading to a string of land records which cut a swath westward along the frontier. Thomas's parents were Darius and Hannah [Anna in other records] Hyde, formerly of Derbyshire, England. In the areas where land records were located, there was also a string of puzzling marriages for Darius. Once a map of the Mormon Trail was overlaid, the route and circumstances of Darius and Hannah's westward move began to fall into place.

There is no further record of Thomas's mother Hannah Hyde after her baptism into the LDS Church in June of 1875 and it is thought that she passed away prior to Darius remarriage in Feb 1877. Thomas himself did not become a member of the church and any further connection with his father was not found.

# Darius Hyde from England to America

Darius Hyde was married no fewer than five times - first in England and then four more times in the US. A summary of his marriages is included here for clarity and each of these relationships and children from the marriage are discussed below.

- (1) 4 Dec 1837 Hannah Harrison, Derbyshire, England.
- (2) 22 Feb 1877 Elizebeth "Jones", Crawford County, Iowa.
- (3) 5 Mar 1884 Mary J McIntosh, Pottawatomie County, Iowa.
- (4) 26 Aug 1888 Louisa Henderson, Monona County, Iowa.
- (5) 1 May 1889 Mrs Eliza Miller, Douglas County, Nebraska.

#### First Marriage - Hannah Harrison

Children:

1) Lucy Ann Hyde b. 24 Oct 1838 Shaw-Moor, Stayley. The birth was registered in Ashton under Lyne in Lancashire and shows parents Darius Hyde and Hannah Hyde, formerly Harrison. It shows Darius was a steam loom weaver:

4) Thomas H. Hyde b. c. 1851 in Illinois

The details of this first marriage and parents for Darius and Hannah are discussed later under the heading "Darius Hyde in England." We begin here with their arrival in the US.

Darius is a distinctive - although frequently misspelled - name both in the US and UK. "Hannah" and "Anna" or "Ann" were historically interchangeable in the UK. Darius and Hannah arrived in the US in 1844. They were accompanied by Hannah's sister or sister-in-law, Sarah Harrison.

Ridley Township, Delaware County, Pennsylvania, 1850 Federal Census. (Ridley was named after Ridley, Cheshire, England by some of its original settlers.) https://www.familysearch.org/ark:/61903/1:1:M4HC-PFD This census shows "Davies/Dovius" Hyde, a "factory man" age 40, born in England, his wife Hannah, age 36, also born in England, and presumably their two children, Mary, age 16, born in England, and Ruth, age 10 months, born in Pennsylvania. Daughter Mary's age is inconsistent with her arrival age, but zoom in on the page and her age is actually 11, with a stray mark making the second one look like a six. A checkbox for Ruth notes that she "attended school within the year" which would have been unusual for a ten month old and should have fallen on the line for Mary. Darius was a weaver and it's likely that the factory he refers to was one of the textile mills along Ridley Creek. If you look along the top of the census page, you see Joseph Kenworthy, and on the previous page, Charles Kenworthy, both of England, probable cousins as this branch of Hydes married into the Kenworthy family. At some point, possibly in Pennsylvania, Darius and Hannah were introduced to the Church of Latter Day Saints and began their move westward, through Ohio, Indiana, and Illinois.

The following map shows the major stopping points along the trail, starting with the area where Thomas was likely born, Nauvoo, Illinois, passing through Iowa and Nebraska, to Utah.

Others have conflated Darwin Hyde who purchased land in 1853 in Ottawa County, Ohio, with Darius. Records about Darwin are included at the end of this work to aid the reader in disambiguating the two men.

In 1864, Darius is found in the tract book for Burt County, Nebraska, as the purchaser of a homestead tract, but his homestead certificate was canceled as the land was located too close to the Sioux City and Pacific Railroad.

Darius was enumerated in the 1870 census in Kennebec, Monona County, Iowa. <u>https://www.familysearch.org/ark:/61903/1:1:MDVG-MJF</u> His absence from the 1870 census agricultural schedule suggests that he leased his land to others for farming.

"Early Members of the Reorganized Church of Jesus Christ of Latter Day Saints" by Susan Easton Black (searchable database in Ancestry, <u>Early Members of the Reorganized</u> <u>Church of Jesus Christ of Latter Day Saints - Ancestry</u>; full books in Familysearch <u>FamilySearch</u> <u>Catalog: Early members of the Reorganized Church of Jesus Christ of Latter-day Saints</u>) shows that Darius Hyde stated he was born in June, 1808. Hannah Hyde stated she was born in November, 1813. Both were baptized as members of the Reorganized Church of Jesus Christ of Latter Day Saints on 21 June 1875 by James Caffall, a minister who was responsible for the mission in Western Iowa, Northern Missouri, Kansas and Nebraska. The baptisms suggest that they attended the White Cloud, Kansas Branch, however, it's possible that this is the location where records of the baptisms came to reside, as there are no other records to suggest that Darius and Hannah lived in Kansas. <u>Early members of the Reorganized Church of Jesus Christ</u> <u>of Latter-day Saints: v. 03</u>

A death record for Hannah has not been located but she is believed to have died before 1877. Her death was not mentioned in Iowa newspapers and deaths were not officially recorded in Iowa until 1880. The reader should be aware that there were at least two other women named Hannah Hyde of roughly the same age as this Hannah living in Iowa in the 1800s.

#### Second Marriage - Darius Hyde to Mrs. Elizabeth "Jones"

Mellisa Hyde b 1880, appears to have died young.

Roscoe Hyde Irwin b. 9 Oct 1881, was adopted by Sylvester and Josephine (Bryan) Irwin and appears with them in the 1885 Iowa state census. <u>Woodbury. Census</u> Roscoe died 11 March, 1898, age 16. https://www.findagrave.com/memorial/124010994/roscoe-hyde-irwin

Darius Hyde married Mrs. Elizabeth "Jones," in Union Township, Crawford County Iowa, on 22 Feb 1877. This was the second or possibly third marriage for Elizabeth. An explanation for why she was being called "Jones" could not be found. Some have suggested that her earlier husband Andrew Allen abandoned the family shortly after the birth of their child Effie. Effie May Allen East (1876-1948) - Find a Grave Memorial If true and if a divorce was not granted, Elizabeth would not have been free to marry which would explain her use of an alias.

Elizabeth "Jones" was actually Elizabeth Lawrence, who married Andrew Allen in Monona County, Iowa on 20 Jan 1874.

His death record notes that his parents were Hugh Olin and Elizabeth Lawrence. Iowa, U.S., Deaths and Burials, 1850-1990 - Ancestry.com There was a Hugh O'Linn/O'Lynn living in Magnolia, Harrison County, Iowa in the 1870 census, parents Daniel O'Linn and Ann McCauley. Magnolia was where Elizabeth and her parents were enumerated in the 1860 census. There were several generations of men named Hugh and Daniel O'Lynn in Cushendall, County Antrim, but any connections to the O'Linns in Ireland and Iowa remain unknown.

#### Third Marriage - Darius Hyde to Mary J. McIntosh

On 5 March, 1884, Darius Hyde, age 55, married Mary J. McIntosh, born in Scotland, age 70, in Council Bluffs, Pottawatomie County, Iowa. Darius's parents are given as William Hyde and M. Jackson. <u>https://www.ancestry.com/discoveryui-content/view/4099599:8823</u>

The fate of Mary J. McIntosh Hyde is unknown but she is presumed to have died before the 1885 census was taken in Iowa.

#### Fourth Marriage - Darius Hyde to Louisa Henderson

No children were born of this marriage. Darius Hyde married Louisa Henderson (age 60) in Monona County, Iowa, on 26 August, 1888. <u>Monona. Marriage Records 1878–1881.</u> <u>1881–1890, Marriage Registers 1916–1917</u> It was the third marriage for Louisa. <u>https://www.familysearch.org/ark:/61903/1:1:XJ8G-86X</u> She was enumerated in the 1885 Iowa state census as divorced. <u>Iowa, U.S., State Census Collection, 1836-1925 - Ancestry.com</u>

The death certificate for Louisa's daughter Elizabeth Eayrs (Ayers) lists Louisa's maiden name as Welwiemer. She had six children with her first husband John Boiser, Aurelia, Amelia, Amelius "Melius", Rosella, Rosetta, and Elizabeth "Betsy". She married John C. Henderson 29 Oct 1877 in Monona County, Iowa, second marriage for both, no children. <u>https://www.findagrave.com/memorial/139005810/louise-henderson</u>

Louisa was still living when Darius married again.

#### Fifth Marriage - Darius Hyde to Mrs. Eliza Miller

Darius apparently moved to Council Bluffs, Iowa, after he married Louisa (more on their relationship later). He was included in a directory for the year beginning August 1, 1889. <u>https://www.familysearch.org/ark:/61903/1:1:6ZVM-Z828</u> On 1 May 1889, he married Mrs. Eliza Miller in Omaha, Douglas County, Nebraska, which is just across the river from Council Bluffs. Further information concerning Mrs. Miller has not been located. The surname Miller occurred frequently in the area at that time.

# HE GOT REDUCED RATES.

#### An Old Man Who Objected to Paying \$2 for a Marriage License.

An old English couple who have decided to divide their joys and sorrows were united in the holy bonds of wedlock yesterday morning by Judge Wade. The groom is seventysix and his blushing bride is now about to gaze upon her sixty-fourth summer. Their names are Darius Hyde and Mrs. Eliza Miller.

"Strange, isn't it, that they have gone up!" remarked the groom as he tottered into the justice's office on the arm of his fiance.

"Who's gone up?" responded the judge. "These here marriage licenses. That fellow up to the court house made me pay \$2 for one. Heretofore I have been accustomed to paying only \$1."

"Why didn't you send your grandson around to get it himself, if the price was too much for you?" queried the justice.

"It weren't for no grandson nor no son, sir," was the reply. "It's for meself and this young lady."

"I beg your pardon. I don't blame you for kicking. The clerk should have given you a reduction."

"Why, sir? I would have been willing to pay as much as I used to."

"You should have been given a reduction on the customary fee for the reason that you have not long to use it, and because you have been buying them at wholesale."

"Yes, but I'll bet I'll never pay more'n a dollar again. We're ready to be tied now, yer honor."

The knot was tied.

Seventy-five cents was tendered the court for its services. The old gentleman took the judge at his own proposition on reductions.

Darius Hyde, a "bloomin" Englishman who has been "bloomia" for lo, these seventy-six years, and Elizabeth Miller, who now breathes the fresh May breezes of her sixty-second spring, walked up the steps and into the office of Judge Wade yesterday afternoon and announced to the judge that they were desirous of being united in the bonds of matrimony. The judge indicated to them, by a graceful gesture, the particular spot upon his office floor which is usually occupied by people about to take this important step, and the aged but frisky pair ranged themselves in shape to catch the full meaning of the solemn words. When the judge was looking over the marriage license, Mr. Hyde, the somewhat embarrassed groom. broke the silence in this wise."

"In all my experience of getting married I never paid over \$1 for a license till today. That clerk up there at the court house had the gell to charge me \$2.50 for that paper you hold there, judge. It is an extortion, but I had to have it."

After the judge had finished the ceremony the groom asked how much the bill was. The judge repiled that it would be \$3.

"You don't mean to rob a man on his wedding day, do you judge?" inquired the astonished groom. "I haven't but seventy-five cents in my pocket. I thought you wouldn't charge me over fifty cents. If you want the seventy five, though, you can have it."

The judge took the seventy-five cents.

Supplementary information in the marriage record names Darius's parents as William Hyde and Mary. Mrs. Miller's maiden name is unknown, her age approx 62, per the marriage record she was born in England circa 1827. The marriage record gives Darius's age as 76, so an approximate birth year of 1813. No children.

#### **Return to Louisa?**

In the 1895 Iowa State Census, Darius Hyde was enumerated with Louisa, his fourth wife, and they each were noted as married, although she was enumerated as Louisa Henderson. His religion is shown as Latter Day Saints and hers as Lutheran. He is listed as 82 years old with a birth year of 1813. <u>https://www.familysearch.org/ark:/61903/1:1:VTQ3-6Y1</u>

Darius died sometime after the 1895 census was taken. There is a reference on son Roscoe's memorial page (above) that Darius "Abe" Hyde was "killed in a holdup", which cannot be confirmed. This is unlikely as there are no newspaper accounts involving Darius's death. There's an item in the Mapleton Press, an Iowa area newspaper, dated Thurs Nov 8, 1917, pg 2, "Abe Hyde and son Roscoe, of Ramey, Minn., have returned to Mapleton after working at Ramey for a number of years." This suggests that Darius may have been conflated with his son Abram/Abe. Abe named one of his sons Roscoe after his brother Roscoe. Abe had been "in ill health for many years" and unfortunately took his own life at age 80. https://www.findagrave.com/memorial/31273254/abram-hyde

# **Darius Hyde in England**

Darius Hyde's first marriage was to Thomas Hyde's mother, Hannah Harrison. https://www.familysearch.org/ark:/61903/1:1:KB6N-QB4. Their marriage was solemnized in the town of Glossop, in the parish of Glossop, County of Derby, England. At the time of his marriage, Darius was living in the chapelry of Mellor, a subdivision of the parish of Glossop, Hundred of High Peak, Derbyshire.

The marriage record shows that on 4 December 1837, Darius Hyde, of full age (over 21, so born no later than 1816, birth year in American records ranges between 1808-1813), bachelor, weaver of Mellor, Derbyshire, father William Hyde, farmer. Bride Hannah Harrison, of full age, spinster, of Comstall (sic) Bridge (in Cheshire), father Joseph Harrison, shoemaker. Married in the church by banns according to the rites and ceremonies of the Established Church by Christopher Howe, Vicar. Darius and Hannah both signed with their mark X. Witnesses were George Webb and Robert Winterbottom. George Webb was a crofter of Mellor and he and his wife Sarah Hambleton were married at the same time as Darius and Hannah, and in fact Rev. Howe initially wrote Hannah's last name as Hambleton before correcting it.

Hannah Harrison was christened 28 July, 1816, in Glossop by Rev. Charles Howe, the same vicar who later married her. She was the daughter of Joseph Harrison, then of Chisworth, shoemaker and his wife Mary. (Disambiguation note - Hannah Harrison who married Brown was the daughter of Abraham Harrison per marriage record.)

After their marriage, Darius and Hannah were living in Tameside where Darius worked as a steam loom weaver. The birth records for Lucy Ann and Mary identify an area around Millbrook, Stalybridge, Cheshire. Besom Row, the recorded place for Mary's birth in 1840, is clearly visible on this map:

A christening record for Darius Hyde could not be located. Three of the five marriage records for Darius give his father's name as William (1837, 1884 and 1889). The other two do not provide background information. The 1837 record gave his father's occupation as "farmer." The 1884 marriage gave his mother's name as "M. Jackson" and 1889 called his mother simply "Mary."

Two years prior to his marriage, Darius was convicted of poaching in the township of Mellor and sentenced to three months of hard labour in the county jail at Derby (to be extended to six months if he could not post a bond guaranteeing that he would not offend again for a year). This and the marriage record establish him as a known person in the area. And to some extent, it suggests that the prospect of land ownership and a new life would have a strong appeal for him.

https://www.familysearch.org/search/full-text/results?count=20&q.anyPlace=England%2C%20U nited%20Kingdom&g.fullName=%22darius%20hvde%22%20 Cheshire and Derbyshire have for centuries had a large concentration of people bearing the surname of Hyde, and one needs to be enormously careful when doing research. While searching for the parents of Darius, quite a few Williams were ruled out, as they were not farmers in 1837.

Even so, two Williams were identified as possible fathers to Darius - first cousins -William Hyde b. 1776 who married Mary Wood and lived at Mill Brow, Mellor, and William Hyde b.1777 who married Nanny Jackson and lived at Bradshaw, Mellor. A William Hyde who married an M Jackson, as suggested by the 1884 marriage record for Darius could not be located.

#### Note on Geographic Locations and Latinised Names

With few exceptions, this family in England in the 1600-1800s lived in a small area in the Counties of Cheshire and Derby (most of which is now in "Greater Manchester") and events described occurred in an area generally bounded as follows:

On the West - Stockport - where many of the marriages occurred at St. Mary's Church, Stockport, which was the parish church for Bramhall and the Chapelry of Marple before Marple became a parish in 1783.

On the South - Mellor in the County of Derby (not to be confused with Mellor in Lancashire) On the East - by the Peak District National Park - just east of Upper Bradshaw, Pistol and Spring Bank.

On the North - by Glossop and Ludworth

All references herein to Mellor - are to Mellor in Derbyshire. Burials at Mellor are in St. Thomas Churchyard except burials in the "Dissenters Burying Ground."

The reader should be aware that place names were often shortened in historical records and that parts of names were eliminated which can cause confusion about a location.

Between 1754 (Hardwicke's Marriage Act) and 1836 (General Registration Act), marriages in England were required to be performed in the "Mother Church" for the parish which explains why so many marriages for this line were performed at St. Mary's Stockport, rather than in the nearby chapel. But even before 1754, it was common practice for marriages to occur in the "Mother Church" while baptisms generally occurred in the closest chapel.

Before 1733, parish registers tend to be in Latin and names therein were "Latinised" so John appears as Johannes/Johanni; James as Jacobus/Jacobi; Mary as Maria etc. There are numerous resources to aid in reading Latin records such as these: <u>England Latin Versions of</u> <u>Given Names - International Institute • FamilySearch</u> and Latin in Parish Registers and Latinised Names at <u>Slide 1</u>.

Like many Hydes in Cheshire and Derbyshire, there are grafts on many of the online trees for the Hyde family of Mellor. Here is what is documented in parish registers and wills:

#### **Generation One**

#### John Hyde and Elizabeth (possibly Brocke) of Mellor, Derbyshire

There are few surviving records for this couple: no birth, marriage or death dates can be confirmed. Existing records refer to John as "of Mellor" to differentiate him from a few other John Hydes in the area. He and his wife were both probably born circa 1625 and married approximately 1647, based on the baptism date of their son Thomas.

John is known to have married an Elizabeth and to have been living in Mellor in 1658 from the baptismal record in Marple for their son Jonathan. A search for a John Hyde who married women named Elizabeth in Derbyshire or Cheshire in the relevant timeframe (1628 to 1658) yielded only one result, the marriage of John Hyde to Elizabeth Brocke at St. Mary's Church, Stockport, in 1645 on Easter. <u>https://www.familysearch.org/ark:/61903/1:1:FWMV-ZXL</u> Of course, John could have married his Elizabeth in a different county or the record of their marriage may not have survived, but the timeframe and geographic location are correct for this John. Elizabeth was baptised in 1625 at St. Mary, Stockport, daughter of Raphe Brocke of Bramhall, Cheshire https://www.familysearch.org/ark:/61903/1:1:F3JD-K4L

This is likely the death record for John Hyde married to Elizabeth: Johannes (John) Hyde of Marple Bridge bur. Mellor 15 Oct 1685.

Before it was called Marple Bridge, it was part of the township of Ludworth. In the Ludworth Hearth Tax Return of 1670 there were 50 families living there, including several Hides, each with one hearth: Ellen Hide, Ralph Hide, Robert Hide, and Thomas Hide: <u>https://freepages.rootsweb.com/~dusk/genealogy/hearthtax/ludworthhtax.html</u> More research is needed before John and Elizabeth of Marple Bridge can be linked to any earlier families.

John and Elizabeth likely had other children but parts of surviving parish records are no longer legible.

Elizabeth Brocke's father Raphe (Radulfus) Brocke/Brock was a tenant on the Bramhall estate in 1645. <u>Chester. Deeds 1200–1600</u> and died there in 1652 and was buried at St. Mary's Stockport, Cheshire on 29 Oct 1652.

John Hyde appears in the Hearth Tax for Mellor 1662-1663 with two hearths: <u>https://www.marplelocalhistorysociety.org.uk/archives/items/show/1465</u>

Elizabeth's maiden name is occasionally given as Harvey in unsourced trees, but there is no evidence for it and it appears that she has been conflated with the Elizabeth Harvey who married John Hyde in 1660's Connecticut.

Note that there was a Jonothan (note sp) Hyde baptised 27 May 1666 at St. Mary, Stockport, Cheshire, father John Hyde <u>https://www.familysearch.org/ark:/61903/1:1:FWM2-ZM8</u> This Jonothan, son of John Hyde, was buried 3 Oct 1669 at St Mary, Stockport. There is no evidence for a maiden name for Dorothy despite numerous public trees claiming that her maiden name was Hamnett. Occasionally her parents are listed as Edward Hamnett and Margaret Barnett, who were married 25 Oct 1667, both of Aston, Bunbury parish, Cheshire, approximately 35 miles away. This might be possible were it not for the Hamnetts moving to Wrenbury, Nantwich, Cheshire, approximately 55 miles away from Mellor as the crow flies, where their children were baptised. They are not known to have had a daughter Dorothy. From a purely geographic standpoint, the closest Hamnett family to Mellor was still some distance away, gentry rather than yeomen, and there is no evidence that they had a daughter named Dorothy. There were approximately five women named Dorothy of suitable age close to Mellor in the area of the Derbyshire - Cheshire border. So, until evidence for a maiden name appears, Dorothy's maiden name should remain as "unknown."

James was identified as being of Werneth at the time of his marriage, of Bramhall, Cheshire, at the time of the birth of his first child in 1720, of Marple by 1722, and Mellor by 1728. He lived at Lower Hall in the Parish of Mellor, where he died in 1744 leaving a Will dated 12 April 1744 (probated 17 Oct 1744) which named his wife Hannah, son James, daughter Elizabeth who had married Jonathan Dowley, son Thomas, daughter Mary, and son John (with Thomas, Mary and John all being under age 21). James was identified as being a husbandman.Transcription at <u>Hyde Wills</u> **James Hyde of Mellor 17 Oct 1744** (please note that the date in the heading is the date of probate - the will was signed on 12 April 1744). James identified himself as a husbandman in the 1730 probate records for his father's estate. On May 25, 1744, Ralph Hyde (possibly James's brother or a cousin) filed an appraisal of the cattles and chattels that had been owned by James.

This James is often conflated with the **James Hyde of Prestbury, Cheshire,** who married **Hannah Harrop** on 24 Feb 1716. Hannah was likely the daughter of Thomas Harrop who was baptised at Prestbury in 1701. There were several men named James Hyde living in the area of Prestbury during this time. The following children were born to a James Hyde and baptised in Prestbury between 1716 and the death of Hannah Hyde at Prestbury in 1746. Except where noted, the children may not all have been children of James Hyde and Hannah Harrop. All of these records are from the baptismal and burial records for Prestbury: **Joseph** son of James bap 14 Feb 1720/21 (Joseph son of James of Prestbury buried 17 Jan 1721/2); **William** son of James, labourer, and Hannah his wife, born 21 Aug 1724, bap 30 Aug; **Thomas** son of James Hyde of Butley, bap 24 Nov 1728 (Thomas died 1730, noted as father James, mother Hannah); **Hannah** bap 13 Oct 1740 daughter of James of Adlington (Hannah d. of James Hyde of Adlington, buried Prestbury 1757); **John** son of James Hyde (jun?) of Adlington, bap 2 Nov 1743 in Prestbury.

Hannah Hyde of Prestbury died in 1746. James may have been living at this time, as Hannah is not noted as being a widow in the record. <u>https://www.familysearch.org/ark:/61903/1:1:F38N-93D</u> Adlington was a chapelry of Prestbury until 1866. Butley is a township in the Parish of Prestbury. The careful reader will have noted that the August 1724 birth of William to James and Hannah of Prestbury conflicts with the January 1724/5 birth of Thomas Hyde to James and Hannah of Marple. James who married Hannah Harrop was buried in Prestbury at a later date, more research is needed for disambiguation of at least three James Hydes of Prestbury but that shall wait for another work as it is not relevant to this lineage.

Nanny Jackson was the daughter of Abraham Jackson of Lee Head, Glossop, who left a Will dated 17 April 1826. Lichfield. Probate Records 1842, Wills 1842 In his Will, he referred to his daughter as Nanny Hyde and to William Hyde as his son-in-law and provided for a share of his estate to be held in trust with the interest paid to William until the youngest child of his late daughter Nanny reached age 21. He mentioned that the eldest child of Nanny was John. Abraham Jackson's other children were James Jackson, Jinny B...., Hannah Rowbottom, and Susan Rowbottom. Hannah Jackson Rowbottom was the wife of Moses Rowbottom who is mentioned as a brother-in-law to William Hyde in his Will of 1841 discussed below.

But where is Darius? That Darius was the son of William of Bradshaw Hill is known from the death record for Darius's daughter Lucy Ann, who died of phthisis (pulmonary tuberculosis) on 2 April 1840 at Bradshaw Hill, Mellor, in the presence of her grandfather William Hyde.



"William" Hyde (son of William and Nanny Jackson) born in 1808 was actually Darius. He used his middle name or a chosen name as an adult to differentiate himself from other William Hydes in the area. A birthdate of 1808 and a mother's maiden name of Jackson are consistent with records for Darius in the U.S.

Given the seven year gap between the birth of Alise in 1808 and the birth of Betty in 1815, there were likely other children who have not yet been identified.

Mary (Wood) Hyde died and was buried at Mellor, Derbyshire, in 1832 at age 56, making her year of birth c. 1776. Her abode was noted as being Mill Brow Ludworth.

#### Conclusion:

While a birth record for a man named Darius Hyde could not be found, the death record for his daughter Lucy Ann Hyde identifies both Darius and his father, who was William Hyde of Bradshaw Hill, Mellor. This, combined with other records - court, census, marriage to Hannah Harrison, and birth registrations for their children Lucy Ann and Mary, show that Darius was baptized William Hyde on 12 Jan 1808 in Allostock, Cheshire, the son of William Hyde and Ann/ Nanny Jackson of Bradshaw, Mellor. He began using his middle or chosen name sometime before 1835, when he was convicted of poaching. The probable reason for the name change was to avoid being mistaken for any of several other William Hydes in the area, including William, the son of William Hyde and Mary Wood, and also another William Hyde who was baptized 18 Jan 1808 at Marple Bridge, parents Robert and Mary Hyde.

Darius and Hannah's son Thomas Harrison Hyde of Gasconade Missouri had to fend for himself on the western frontier from a fairly young age, and it's not clear how much he may have known about his extended family back in England, or even his own siblings and half-siblings. What is clear is that the statement made by the Advertiser-Courier, "Nothing is known about his relatives or his past", is no longer true.

In the name of God Amen I James HYDE of Mellor in the parish of Glossop and County of Derby Husbandman being much indisposed in body: but of Disposing mind and memory (praysed be God for the Same) Do publish and Declare this to be my Last Will and testament (hereby revoking and Making Void all former Wills and Testaments by me heretoforemade) and first I will that all my just Debts and funeral Expenses and the Charges of the probate of this my will be paid. And in the Next place I give and bequeath unto Hannah my Loving wife and James HYDE my son all my whole Substance Cattles and Chattles in trust that they will bring up my younger Children until they attain the Age of twenty one years (or be so first unmarried) if they will be governed by them and stay with them. And my will and mind is that my Wife or Son pay unto each and every of my younger Children Thomas, Mary, and John HYDE as the Severally attain the Age of Twenty one Years the sum of fifty pounds if it so happen that god so prosper my Wife and Son that their Affects at the time will allow to give them So much [leaving] a [Sufficient] for my wife and an Equal Share to my Son James HYDE Item I give and bequeath unto my daughter Elizabeth wife of Jonathan DOWLEY they Sum of twelve pence I having given in hand in Money goods and Charges as much as I give the rest of my Younger Children Item I give to my Son in law Jonathan DOWLEY the sum of twelve pence All the rest Residue and Remainder of my Effects Cattles and Chattles if any be after my Will is performed I give Devise and bequeath unto Hannah my Loving Wife and my Son James HYDE Lastly I Do nominate ordain constitute and Appoint Hannah My Loving wife and James HYDE My Son executrix and Executor of this my Last Will and Testament in Witness whereof I have hereunto Set my hand and Seal the Twelfth Day of Aprill in the year of Our Lord one thousand seven hundred and forty four.

And I Give one other sixth part of such Goods unto all the children of my Daughter Elizabeth deceased who was wife of Robert HEGINBOTHAM of Longlee in the said County of Derby to be equally divided amonst them. And I Give and Bequeath one other sixth part of such Goods unto the children of my eldest son James late of Marple in the County of Chester equally to be Divided amongst them share and share alike. And I also Give and Bequeath the Remaining Three Parts of such Goods unto my sons Ralph and **Thomas** and my Daughter **Ann** Equally amongst them. And in case either of my said sons or Daughter shall happen to Dye in the life time of my said Wife and before her Second Marriage, Then I Give and Bequeath the shares or parts of such Goods to the Children of him or her or them so dying. Then as to the Residue of my Personal Estate I hereby will order and Direct that the same shall be applied in the Discharge of my Debts, Funeral Expenses the Probate hereof and such Legacies as are herein after mentioned.

Now as for and Concerning the whole of my real and freehold Estates together with the Residue of my Personal Estate whatsoever and wheresoever within the Kingdom of England I hereby Give and Devise the same unto my second son **Ralph HYDE** of Offerton in the County of Chester and my said son in law Robert HEGINBOTHAM their Heirs Executors Administrators and Assigns for Ever Upon Trust and to the Intent and Purpose that they the said **Ralph HYDE** and **Robert HEGINBOTHAM** and the survivor of them and the Heirs Executors Administrators and Assigns of such survivor do and shall with all Convenient speed after my Decease Sell Dispose Assign and Convey all and every my Real and Freehold Estates by way of Auction to the Highest or best Bidder And all Money arising therefrom together with the Residue of my personalty, pay and apply the same to such uses as are herein after mentioned and by me Given and Bequeathed . And this further Trust and Confidence and to this further Intent and Purpose that they the said **Ralph HYDE** and **Robert HEGINBOTHAM** and the survivor of them and the Heirs Executors Administrators and Assigns of such survivor do and shall with all convenient speed after my Decease be Sale and Disposition of a Competent part of my said Freehold Estate or otherwise as they in their Discretion shall see most proper and Expedient raise and Levy the sum of Two Hundred Pounds and place and put out the same at Interest or let the said sum of Two Hundred Pounds lye and remain at Interest upon my said Freehold

Estate at Bradshawhill aforesaid and pay and apply such the Yearly Interest or the sum of Nine Pounds Yearly Annuity unto my said wife and her Assigns for and during the Term of her natural Life or her Marriage again on every the Twenty second day of November and the fifth day of April by even and equal portions the first payment thereof to commence and be paid on such of the said Feast Days or Times as shall first and next happen after my Decease, which said Yearly Interest of Two Hundred Pounds or Annuity, I hereby Will Order and Direct shall be in lieu and full satisfaction and Discharge of and for all Dower and Thirds at Law which she my said Wife can or may have claims Challenge or Demand of into or out of any of my Personal real of freehold Estates wheresoever the same now are or be or which I at any time heretofore have been seized off or shall or may at any time hereafter during her Coverture be seized off.
